**ALL Pairs are responsible for arranging their matches (at Neutral Venues) and submitting results Before 9PM 8th December, this will not be extended.**

MATCHES ARE BEST OF 5 FRAMES - if a Pair wins 3 frames there is no need to play the remaining frames.

If a Pair has difficulty contacting the other Pair they must contact the Div Reps or Committee for assistance. In general, if results are not received before the cut-off then neither Pair will go through to the next round. However, the Committee may overturn this decision if a Pair proves they have made attempts to arrange the match and they have escalated to the Div Reps/Committee beforehand
